(1) Certified or Settled applications -- the number of families eligible for relocation benefits. Families are considered relocated when they occupy their replacement homes.

(2) Contracts in process -- these families are in the process of building or buying homes, and have not occupied their homes.

(3) Seeking homes -- families who have received home acquisition counseling; are selecting their homes, and have not signed a contract.

(4) Families' cases are typically closed 2 years after relocation, but can be kept open if additional time is needed for warranty, referrals, etc. Open PM figures include these clients.
